Affiliate Reward Program

This Affiliate Reward Program (“**Reward Agreement**”) is entered as of the date of the last signature below (“**Effective Date**”) between Elite Small Business Advisors, Inc. (“**ESBA**”), a Wyoming corporation, and the party indicated on the signature page (“**Affiliate**”) and is made pursuant to the Affiliate Agreement (“**Affiliate Agreement**”) in effect between the Parties. This Reward Agreement outlines the terms and conditions under which Affiliate will qualify for and receive a reward for achieving specified Sales Milestones (“**Reward**”). Capitalized terms not defined below are defined in the Affiliate Agreement. All terms and conditions of the Affiliate Agreement remain in effect and apply unless expressly modified below.

1. **Purpose.** ESBA may periodically offer one-time or periodic Rewards for hitting Sales Milestones. The Sales Milestones and Rewards will be specified in advance substantially in the form attached as Schedule A (Reward Terms).
2. **Eligibility.** Affiliate will qualify for the Reward if Affiliate achieves the amount of sales (“**Sales Milestone**”) within the eligibility period specified in the Reward Terms. ESBA may specify additional and/or modified eligibility requirements in the Reward Terms. Affiliate will receive only the Reward for the highest Sales Milestone achieved, and is not entitled to multiple Rewards during the same Sales Period (specified in Schedule A).
3. **Available Rewards.** ESBA may make different Rewards available from time to time that may consist of physical Rewards (e.g., Apple iPad), travel packages, and additional discounts applicable to the purchase of Becoming-Bankable Licenses. Unless otherwise specified in Schedule A, Rewards are non-transferable, non-exchangeable, and may not be redeemed for cash or any other alternative unless agreed to in writing by ESBA. ESBA reserves the right to make different Rewards and/or eligibility criteria available to Affiliate and other affiliates or service providers of ESBA at its discretion.
4. **Conditions.** To receive a Reward, Affiliate must: (1) comply with all terms outlined in this Reward Agreement, the Reward Terms, and the Affiliate Agreement; and (2) ensure that no fraudulent activity, chargebacks, or refunds impact the Sales Milestone. Unless otherwise specified in the Reward Terms, ESBA will verify all Qualified Sales within 30 days of achieving the applicable milestone. If any Qualified Sales are deemed invalid due to refunds, chargebacks, or non-compliance, Affiliate will not qualify for the Reward.
5. **Delivery.** Once the Sales Milestone is verified, ESBA will deliver the Reward to the Affiliate within thirty (30) days, or the time specified in the Reward Terms. Unless otherwise specified in the Reward Terms, ESBA will cover shipping costs to the address specified in the Affiliate Agreement, unless another address is provided by Affiliate and agreed to by ESBA. Affiliate is responsible for additional shipping fees if shipment is requested to any other address.
6. **Taxes.** Affiliate is solely responsible for reporting and paying any taxes associated with the receipt of any Reward. ESBA may issue a 1099 form or equivalent as required by applicable law.
7. **Termination and Forfeiture.** Rewards will not be provided if: (1) the Affiliate Agreement is terminated before the Sales Milestone is achieved; (2) Affiliate breaches the terms of the Affiliate Agreement or this Reward Agreement; or (3) fraudulent activity, including, without limitation, falsifying sales, is discovered. ESBA reserves the right to withhold or revoke any Reward if eligibility criteria are not met in full.
8. **No Warranty or Replacement.** ALL REWARDS PROVIDED UNDER THIS REWARD AGREEMENT ARE OFFERED "AS-IS" WITHOUT ANY WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ESBA IS NOT RESPONSIBLE FOR REPLACING REWARDS THAT ARE LOST, DAMAGED, OR BECOME UNUSABLE AFTER DELIVERY. ONCE A REWARD IS RECEIVED, ANY ISSUES, DEFECTS, OR DISPUTES SHOULD BE ADDRESSED DIRECTLY WITH THE MANUFACTURER OR SERVICE PROVIDER. ESBA MAKES NO GUARANTEES ABOUT THE PERFORMANCE OR CONDITION OF ANY REWARDS AND IS NOT LIABLE FOR ANY DAMAGES RESULTING FROM THEIR USE.
